Members are entitled to use all University Sports Centre facilities included in their membership scheme (checked box above: Basic or Basic+).

Obligation to show identification: You may only enter the University Sports Centre facilities with your student ID, staff ID or University Sports Centre visitor's pass.

Fee: The membership fee is based on the membership type you have chosen (Basic or Basic+). The fee will be debited monthly from your bank account (see direct debit mandate).

Cancellation: After the initial membership period has ended, cancellation is possible monthly. The University Sports Centre's administration must receive your notice of cancellation two weeks prior to the next possible contract end. Please include your current e-mail address on the notice of cancellation. Cancellations will be confirmed within 10 days via e-mail!

Direct debit mandate: University Sports Centre membership is reasonably priced because we try to keep administrative expenses as low as possible. This is why membership is only possible if payment is received by direct debit.

Direct debit can only be done from a German bank account. If you have an international bank account, please contact the Infopoint or the University Sports Centre's administration (Sekretariat).

Cash payment: Cash payments are accepted; however a 5 € administration fee will be charged.

Changing your personal data: Please inform us immediately about changes of address, name or bank account details in written form or via e-mail.

Freezing contracts: You can freeze your contract for a certain period of time given you have an appropriate reason. Appropriate reasons include diseases, injuries, internships or employment outside of Göttingen. Please submit a timely, informal written explanation with the relevant documentation. It is not possible to freeze your contract **retroactively**.

Data protection: All personal data are subject to data protection laws. The principle of data minimisation applies during online registration and when registering for sports activities. The following data will be recorded during registration: Last name, name, affiliation, e-mail address, address and direct debit account data for activities that require a fee. As a University Sports Centre member, you consent to your data being processed for purposes of organisation and administration. Photos taken at University Sports Centre events are also made available online on different media. By participating in such events, you automatically consent to the non-remunerated use of the pictures on ZEHS websites.
